We shared Ayushi's concern on feedback with client, please see below response:-

The moderator should already be familiar with the type of respondent, hospital type, and brands /processors being used before the interview just from these updates.

We are not sure what mock KOC you are referring to. To my knowledge, only the moderator briefing on 01/20 and the Civicom walkthrough for the platform took place. Please clarify which call you are referring to.

To address technical difficulties, Ayushi should call out to the 3rd party on the phone for assistance if she is not comfortable/not supposed to help respondents connect to the call. There are Civicom staff and recruiters are on the line. They should be helping respondents. If they don't proactively do that, Ayushi needs to ask them to step in.

We are speaking with the client team about schedules and will follow up on connecting your team with them to talk through the research background and next steps.

Dear Garima,

Hi! Good morning. Trust you are doing well.

Thank you, for sharing the feedback.

We have had a long chat with the moderator and before we deep dive into our response, we would like to share that our moderator is highly qualified and has successfully completed numerous healthcare projects in Japan. Further, we had a mock kickoff call with the client that went on for over an hour and the client also did not have any negative feedback to share post the call. So, receiving the below feedback wasn't a pleasant thing for us. However, we would look at the feedback as a constructive one, and will surely work towards client delight and wowing them with our work on the remaining interviews.

Please find below my responses pertaining to the feedback shared with us:

1. The moderator hasn't been shared any screener document beforehand to know about the type of respondent.
  1. She is getting to meet them while they are starting with the interview. So, I am not sure who is the person responsible for doing that, whether it will be our team or the client's team who is scheduling the interview.
  2. The only thing our moderator has is the DG.
  3. Request - we need to send the screener document to the moderator beforehand for her to spend some time reading about the respondent and be better prepared.
2. On a few occasions, our moderator has to help the respondent with technical glitches on the call. The respondents aren't aware of how to dial in or connect.
  1. Ayushi has helped the respondents but it's not what she is expected to do on the call. The third party on the call isn't actively sharing the meeting materials or relevant slides (Once Ayushi had to correct them to show the correct slides) in real-time.

2. Hence, while the intent is to carry on with the interview, slight deviations like these during the call will result in some unproductive moments and might put a brake on the conversation flow or the breakage of thoughts.
3. However, we accept that we should be more careful about being on the lookout for the civicom chat windows for client's questions, feedback, probing, etc. and this is something we would definitely work on and ensure this is taken care of immediately.
4. While moderation is a fine skill, it certainly becomes objective as per the client's need. Some clients prefer sticking to the script and getting answers as probing too much or rephrasing frequently can lead to feedback touching BIAS and we wanted to avoid that. however, the follow-up call with the client will allow our moderator and the client to be on the same page and this can be taken care of easily while keeping in mind that these interviews are aligned for a 60 min conversation.

We are fully committed to ensuring that we have a happy client whose objective is achieved with good-quality interviews/insight. Please suggest the next steps regarding the call scheduled between the client and our moderator.
